He backed this amazing achievement up by placing 3rd in the Novice Jumping (500) Final at his first Agility Nationals in Perth 2010. He has qualified in the sporting ring a staggering amazing 136 times.

My beautiful mate is now 12 years old and, as he grows older and a little wobblier every day, I often sit and reflect on his extraordinary career and smile at all we have achieved together.

Many thanks to Cooroorah Kennels for letting me choose this boy, I think I picked a good ‘un! Schooner, thanks buddy, enjoy your well-deserved retirement and I hope we will have many more years together.
